the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **W. E. SHAW, INC., ITS SUCCESSORS AND ASSIGNS, FOREVER:**

ALL that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #84, of a subdivision known as Homestead Acres, Section II, as shown on a plat prepared by Piedmont Engineering Service, dated April 26, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX at Page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Havenhurst Drive, joint front corner lots #83 and #84, running thence along the line of these lots, S. 87-50 W. 241.3 feet to a point in branch; thence following the meanders of said branch, the traverse line of which is N. 3-49 E. 90.1 feet to a point at the joint rear corner of lots #84 and #85; running thence along the joint line of these lots, N. 87-50 E. 243.9 feet to an iron pin on the western side of Havenhurst Drive; thence along the western side of Havenhurst Drive, S. 2-10 E. 90.0 feet to an iron pin, point of beginning.
