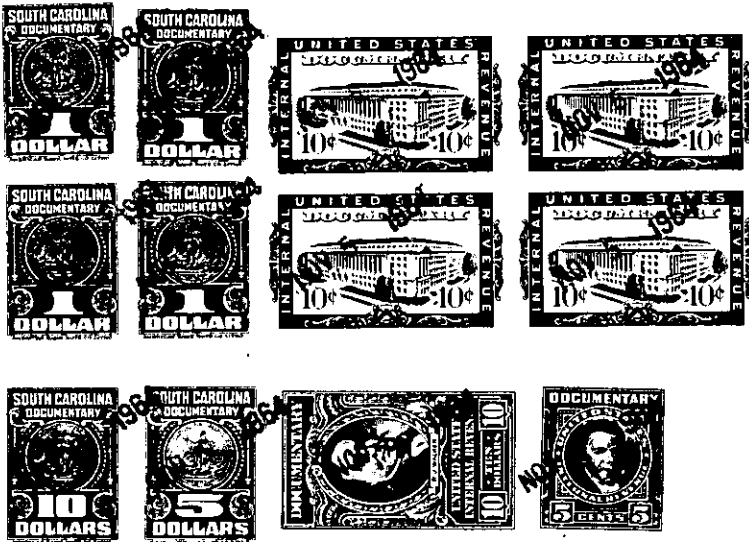
KNOW ALL MEN BY THESE PRESENTS, that I, MYRA N. COYLE,
