All that certain piece, parcel or lot of land in the County of Greenville, State of South Carolina, on the southwest side of the intersection of Brook Forest Drive and Camden Lane, being shown and designated as Lot No. 27 on plat of Belle Meade, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book EE, at pages 116 and 117, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Brook Forest Drive at the joint front corner of Lots Nos. 28 and 47, and running thence with the joint line of said lots, S. 69-44 W. 148.6 feet to an iron pin in the line of Lot No. 26; thence with the joint line of Lots 27 and 26, N. 27-20 W. 87.7 feet to an iron pin on the southern side of Camden Lane; thence with Camden Lane, N. 51-17 E. 75 feet to a point; thence continuing with Camden Lane, N. 55-24 E. 53 feet to a point; thence with the curve of the intersection of Camden Lane and Brook Forest Drive, the chord of which is S. 77-30 E. 43.7 feet to a point on the western side of Brook Forest Drive; thence with Brook Forest Drive, S. 20-16 E. 100 feet to the point of beginning.
