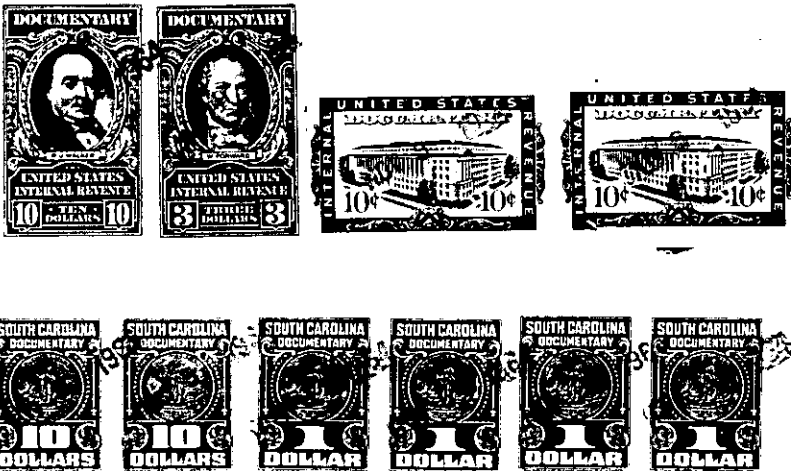
KNOW ALL MEN BY THESE PRESENTS, that WILTON H. McCURRY AND MARY S. McCURRY

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto KENNETH W. HYATT, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land being situated on the Eastern side of Tiffany Drive, near the City of Greenville, County of Greenville, State of South Carolina, known and designated as all of lot #15 and one-half of lot #14, of a subdivision known as Mayfair Estates, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book S, Pages 72 and 73, and having, according to said plat, the following metes and bounds, towit:
