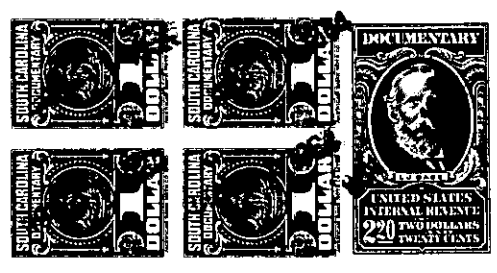
sum of One Thousand Eight Hundred Fifty (\$1,850.00) dollars,
