All that tract, piece or parcel of land in Glassy Mountain Township, Greenville County, State of South Carolina and described as follows: BEGINNING at a monument in the North Carolina, South Carolina State line, which monument stands North 86 degs. 35 mins. West 63.7 feet from the Southwest corner of the 1.45 acre tract (situate in the State of North Carolina) conveyed to Kilburn Mill, a corporation, by M. C. Holt-houser and Julia Holthouser, his wife, by deed dated September 28, 1951, recorded in Book 95, Page 97, Polk County Registry (said beginning point also being the Northwest corner of a 1.74 acre tract situate in Greenville County, State of South Carolina conveyed by Lanier Realty Company, a Corporation, to Kilburn Mill by deed dated August 17, 1951, recorded in Vol. 440, Page 249, Office of Register of Mesne Conveyance for Greenville County, South Carolina); thence with the Kilburn Mill line four calls as follows: South 4 degs. 05 mins. East 54.4 feet to an iron pin; North 85 degs. 47 mins. East 46.6 feet to a stake; South 10 degs. 58 min. West 67.3 feet to a stake; South 18 degs 34 mins. West 69.2 feet to a stake near the Northwest end of the bridge which crosses Vaughns Creek over the dam; thence South 53 degs. 37 min. West 74.4 feet to an iron pin in the Eastern margin of an old abandoned road; thence with the Eastern margin of said old abandoned road 2 calls as follows: North 17 degs. 30 mins. West 64.8 feet to an iron pin; North 0 degs 16 mins. West 110 feet to an iron pin; thence South 87 degs. 09 mins. West 187.3 feet to an iron pin; thence North 3 degs. 54 mins. East 87.0 feet to an iron pin in the North Carolina, South Carolina State line; thence with the North Carolina- South Carolina State line South 86 degs. 35 mins. East 242.8 feet to the Beginning, containing 0.77 acres, more or less.
