the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

C. J. Moody, Jr., his heirs and assigns, forever:

ALL those pieces, parcels or lots of land in Gantt Township, Greenville County, State of South Carolina being known and designated as lots 93 and 95 in Section "A" of a subdivision known as Englewood Estates, as shown by a plat thereof, dated October 1951, recorded in the R.M. C. Office for Greenville County, South Carolina in plat Book "Y", at page 140, and having the following metes and bounds:

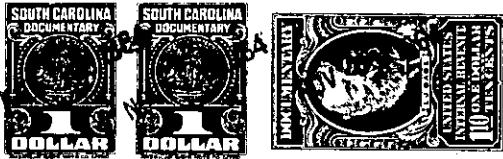
BEGINNING at an iron pin on Woodbine Drive at joint front corners of lots 91 and 93 and running N. 87-30 W. 200 feet to an iron pin on Woodbine Drive, joint front corners of lots 95 and 97; thence with the line of lots 97 and 95 N. 2-30 E. 200 feet to an iron pin at joint rear corners of lots 97, 96, 94 and 95; thence with the rear line of lots 94, 95, 02 and 93 S. 87-30 E. to an iron pin, joint rear corners of lots 92, 90, 91 and 93; thence with the line of lots 91 and 93 S. 2-30 W. 200 feet to an iron pin on Woodbine Drive, the point of beginning.

Restrictions: No residence shall be erected on above property costing less than Five Thousand (\$5,000.00) Dollars; nor nearer than fifty (50) feet to the front line; and no temporary building shall be erected on said property.

This property is conveyed subject to any rights of way now in existence.

Grantee herein to pay taxes for the year 1964.
