unto James R. Mann, his heirs and assigns forever:

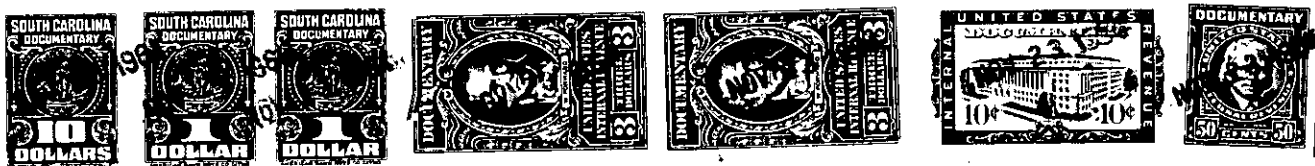
All our right, title and interest, the same being a two-thirds interest, in and to:

All those pieces, parcels or lots of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as the major portion of Lots Nos. 41 and 42 of Property of Vance Edwards as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "P", Pages 128 and 129 and being described together as follows:

BEGINNING at an iron pin on the northwestern side of Ridge Street at the joint front corner of Lots Nos. 40 and 41 and running thence N. 47-08 W. 270 feet to an iron pin at the corner of property heretofore conveyed by the grantors herein to Witt; thence along Witt's line N. 42-52 E. 200 feet to an iron pin in the joint line of Lots Nos. 42 and 43; thence along the line of Lot No. 43 S. 47-08 E. 270 feet to an iron pin on the northwestern side of Ridge Street at the joint front corner of Lots Nos. 42 and 43; thence along Ridge Street S. 42-52 W. 200 feet to the beginning corner.

The above described property is part of the same conveyed to the grantors and the grantee herein by A. E. Holton by deeds recorded in the R. M. C. Office for Greenville County in Deed Book 496, Page 450, and Deed Book 525, Page 249.

As a part of the consideration for the within conveyance the grantee assumes and agrees to pay the balance due on that certain note and mortgage by the grantors and grantee herein to Carolina Federal Savings and Loan Association of Greenville dated July 10, 1956 in the original amount of \$10,000.00 and recorded in the R. M. C. Office for Greenville County in Mortgage Book 684, Page 39, the balance now due thereon being \$2124.36.
