to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Lucille Den and Sally Posey and their heirs and assigns forever:

All that certain parcel or lot of land situated on the south side of Palmer Street in the City of Greer, Chick Springs Township, Greenville County, South Carolina, and being the front one-half portion of Lot No. 44 of the A.R. Wood Estate, shown on a plat thereof by H.S. Brockman, Registered Surveyor, dated July 15, 1939, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the south side of Palmer Street, corner of Lots Nos. 44 and 45, and running thence along the line of said lots, S. 21-30 W. 100 feet, more or less, to an iron pin, new corner; thence a new line, N. 68-30 W. 60 feet to a stake, new corner, on line of Lot No. 43; thence along the line of Lot No. 43, N. 21-30 E. 100 feet, more or less, to an iron pin on the south side of Palmer Street; thence S. 68-30 E. 60 feet to the beginning corner.
