M. C. Office for Greenville County in Plat Book YY, at Page 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Augusta Road U. S. Hwy. 25, joint front corners of Lots 6 and 7 and running thence along the lines of Lots 7, 178, 6 and 179, N. 62-47 E. 415.8 feet to iron pin on Keeler Drive; thence running with Keeler Drive, N. 29-13 W. 240 feet to iron pin corner of Lot 182; thence running with line of Lots 181, 182, 4 and 3, S. 60-08 W. 407.9 feet to iron pin on Augusta Road; thence running with Augusta Road, S. 27-19 E. 240 feet to iron pin point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on said lots; no residence shall be erected on any lot unless said lot has 70 feet, or more, frontage; no residence shall be erected on said lot nearer than 35 feet to the front line; all lots to be used for residential purposes only, except lots fronting on Augusta Road; no outside toilets permitted and sewage to be disposed of by approved septic tanks.
