in consideration of Twenty-Five Thousand and 00/100 (\$25,000.00) - - - - - Dollars, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Parking Consultants, Inc., its successors and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being on the Eastern side of Mallard Street, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a portion of Lots Nos. 1 and 2 as shown on a plat of property of T. A. Snyder prepared by Wm. F. Lee, Surveyor, dated April 25, 1919, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book E, at page 142, and being known and designated as Lot No. 4 as shown on a plat of property of Elizabeth Jones Kyzer, et. al., prepared by Dalton & Neves, dated June 1959, revised March, 1964, and recorded in the R.M.C. BEGINNING at an iron pin on the Eastern side of Mallard Street which iron pin is located 290.7 feet in a Southwesterly direction from the Southeastern corner of the intersection of Arlington Avenue and Mallard Street, and running thence S. 76-14 E. 105.7 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 4; thence with the common line of Lots Nos. 3 and 4, S. 18-14 W. 76.4 feet to an iron pin; thence with the lines of Lots Nos. 2 and 1, N. 76-16 W. 110 feet to an iron pin on the Eastern side of Mallard Street; thence with the Eastern side of Mallard Street, N. 21-15 E. 76.9 feet to the point of beginning.
