the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto E. C. Shipman and Ruby Shipman, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Gantt Township, being known and designated as Lot 9, of a subdivision known as Bel Aire Estates, as shown on a plat thereof, by Madison H. Woodward Engineers, dated May 1956, recorded in the R. M. C. Office for Greenville County in Plat Book KK, at Page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Staunton Bridge Road, joint front corners of Lots 8 and 9 and running thence along the lines of said lots, N. 85-30 E. 216.8 feet to iron pin rear line of Lot 60; thence running with rear lines of Lots 60, 61, S. 4-30 E. 67.5 feet to iron pin rear corner of Lot 65; thence running with rear line of said lot, S. W. 31 feet to iron pin rear corner of Lot 10; thence running with line of said lot, N. 87-50 W. 210 feet to iron pin on Staunton Bridge Road; thence running with Staunton Bridge Road, N. 0-21 W. 33.7 feet to iron pin; thence running, N. 6-10 W. 38.8 feet to iron pin point of beginning.

NO residence to cost less than Seven Thousand Five Hundred (\$7,500.00) Dollars shall be erected on said lot; no residence shall be erected on any lot unless said lot has fifty (50) feet or more frontage; no residence shall be built on any lot nearer than thirty Five (35) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks; no business buildings shall be erected on any lot other than lots fronting on Staunton Bridge Road.

THIS conveyance is subject to all easements and rights of way of record.
