in consideration of TWELVE HUNDRED FIFTY AND NO/100-----Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
C. S. WILLINGHAM, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land, situate, lying and being on the southern side of Hastings Circle, being known and designated as Lot #8 of a subdivision known as Coral Ridge, according to a plat prepared by Piedmont Engineering Service, dated March 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book XX, at Page 19, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Hastings Circle, joint front corner of lots #8 and #9, running thence along the joint line of these lots, S. 0-59 E. 150.8 feet to an iron pin; running thence S. 80-23 W. 35.0 feet to an iron pin; thence S. 54-32 W. 20 feet to an iron pin; thence S. 52-03 W. 26.3 feet to an iron pin at the joint rear corner of lots #8 and #7; running thence along the joint line of these lots, N. 7-50 W. 170.4 feet to an iron pin on the southern side of a turn-around; thence along said turnaround, which line is curved, the chord of which is N. 54-08 E. 15 feet to an iron pin; thence continuing along the southern side of Hastings Circle, N. 85-07 E. 80.0 feet to an iron pin, point of beginning.



It is the intention of this deed to convey all of lot #8. W. N. Leslie, Inc., is joining in with C. S. Willingham, as Trustee to convey that triangular portion at rear of said lot owned by Corporation.

Leslie, who are beneficiaries under said trust. In view of the fact that said property is conveyed to C. S. Willingham, individually, the remaining beneficiaries, W. N. Leslie and J. Claude Hale, hereby join in said conveyance and consent thereto.
