REAL PROPERTY AGREEMENT

- 3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter becoming due to the undersigned, as rental, or otherwise. and howsoever for or on account of that certain real property situated in the County of

, State of South Carolina, described as follows: **GREENVILLE**

ALL that certain peice, parcel or lot of land, with all improvements theron, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situated at the southeast corner of the intersection of Nona Street and Wakefield Street formerly Grove Street, in the City of Greenville, being known and designated as Lots 1 and 2 on a plat recorded in the R. M.C. Office for Greenville County in Plat Book C, at page 150, and being described as follows:
