Joines and Alice S. Joines, their heirs and assigns forever:

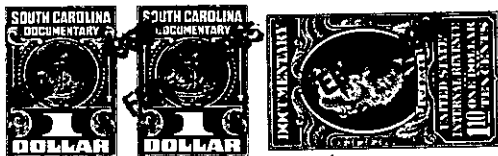
All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the westerly side of Adams Street in the Town of Taylors, S. C., being known and designated as property of Bruce G. Joines and Alice S. Joines as recorded in the RMC Office for Greenville County, S. C., in Plat Book III page 27 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Adams Street, said pin being 351.8 feet in a southerly direction from the Southern Railway right-of-way and running thence with the westerly side of Adams Street S 12-10 E 50 feet to an iron pin; thence S 78-34 W 220.1 feet to an iron pin; thence N 13-47 W 50 feet to an iron pin; thence N 78-34 E 216.6 feet to an iron pin on the westerly side of Adams Street, the point of beginning.
