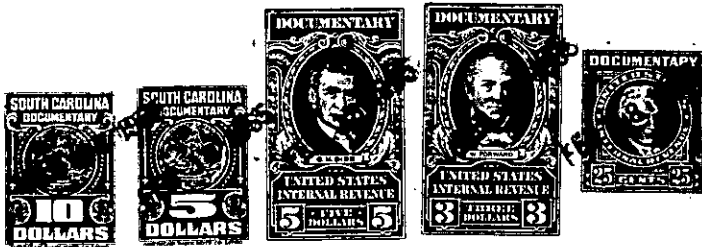
KNOW ALL MEN BY THESE PRESENTS, that Chanticleer, Inc. was merged with Paramount Builders on January 23, 1965. A Corporation chartered under the laws of the State of SOUTH CAROLINA and having a principal place of business at GREENVILLE, State of SOUTH CAROLINA, in consideration of SEVEN THOUSAND FIVE HUNDRED AND NO/100 (\$7,500.00)----- Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto THEODORE CALHOUN JOHNSON, his heirs and assigns,

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Twenty-Two (22) of Section One of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the RMC Office for Greenville County in Plat Book YY at page 97; and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northern side of Chanticleer Drive at the joint front corner of Lots 21 and 22 and running thence with the northern side of Chanticleer Drive N. 84-25 W. 50 feet to an iron pin; thence still with the northern side of Chanticleer Drive N. 87-07 W. 75.9 feet to an iron pin at the joint front corner of Lots 22 and 23; thence with the line of Lot 23 N. 0-44 E. 166 feet to an iron pin in the line of F. H. Earle property; thence with the line of F. H. Earle property S. 89-47 E. 135 feet to an iron pin at the joint rear corner of Lots 21 and 22; thence with the line of Lot 21 S 3-51 W. 174.5 feet to the beginning corner.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the RMC Office for Greenville County in Vol. 713 at page 221 and Vol. 716 at page 321.

This is a portion of the property conveyed to Audubon Forest, Inc. by F. H. Earle by deed recorded in said RMC Office in Vol. 700 at page 383. The name of Audubon Forest, Inc. was changed to Chanticleer, Inc., by instrument recorded in said RMC Office in Vol. 712 at page 481.
