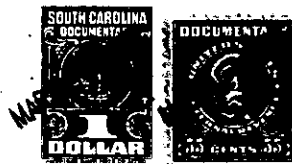

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of One Hundred Fifty & NO/100 (\$150.00) - - - - - Dollars.

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Ray M. Blanton and Doralee Blanton, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated just below the town of Piedmont, South Carolina, being known and designated as Lot 27, of a subdivision known as Monticello Estates, as shown by a plat thereof, by Woodward Engineering Company, dated March 1956, and recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on East Monticello Road, joint front corners of Lots 26 and 27 and running thence along the lines of said lots, N. 71-00 W. 197.8 feet to iron pin rear corner of Lot 45 and 44; thence running with rear line of Lot 44, N. 14-45 E. 80.2 feet to iron pin rear corner of Lot 28; thence running with line of said lot, S. 71-00 E. 203.7 feet to iron pin on East Monticello Road; thence running with East Monticello Road, S. 19-00 W. 80 feet to iron pin point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay 1965 taxes.
