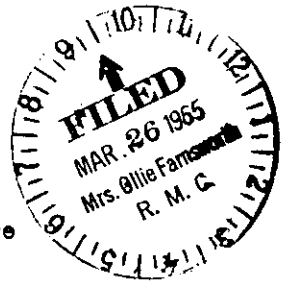

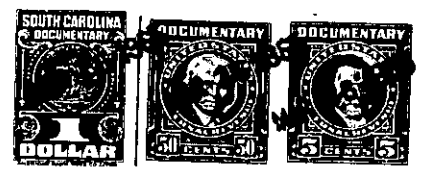
KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Dotch Henson and Margaret E. Henson, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 71 as shown on a Plat of Bellwood Estates, Section 1, dated May 1950 by Dalton & Neves Engineering Company, recorded in the R. M. C. Office for Greenville County in Plat Book GG, at Page 50, and having according to said plat the following description, to-wit:

BEGINNING at an iron pin on South Silver Lake Drive joint front corners of lots 70 and 71 and running thence 75 feet along So. Silver Lake Drive to an iron pin joint front corners of lot 71 and property owned by M. W. Fore known as the lake area; running thence 223 feet, more or less, along M. W. Fore property to an iron pin joint rear corners lots 71, 61 and M. W. Fore; running thence 70 feet along the rear line of lot 61 to an iron pin joint rear corners of lots 61, 70 and 71; running thence 180 feet, more or less, with the side line of lot 70 to an iron pin at joint front corners of lots 70 and 71, the point of beginning.
