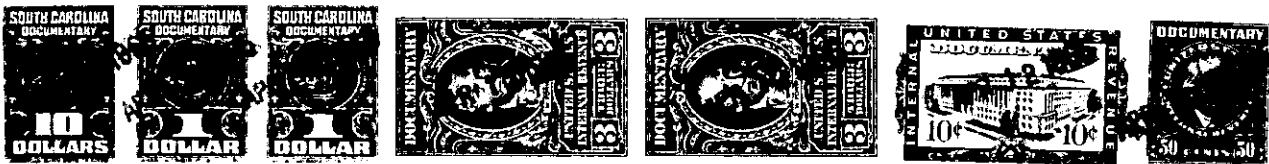
KNOW ALL MEN BY THESE PRESENTS, that We, Richard F. Watson, Jr. and Evelyn P. Watson,

in consideration of Six Thousand and No/100-----(\$ 6,000.00)----- Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto James P. McNamara and Catherine F. McNamara, their heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 13 of a subdivision of the property of the grantors as shown on a preliminary plat thereof prepared by Piedmont Engineers and Architects, and having, according to a plat entitled "Property of Catherine F. & James P. McNamara" prepared by Piedmont Engineers and Architects September 10, 1964, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Darien Way, joint front corner of Lots Nos. 12 and 13, and running thence along the joint line of said lots, S. 7-57 E. 299.7 feet to an iron pin at the corner of a lot belonging to the grantees; thence along the line of that lot, S. 86-50 W. 249.5 feet to an iron pin on the eastern edge of Highbourne Drive; thence along the eastern edge of Highbourne Drive, N. 13-10 W. 135.0 feet to an iron pin; thence continuing along the eastern edge of Highbourne Drive, N. 29-25 W. 100.0 feet to an iron pin; thence following the curvature of the intersection of Highbourne Drive and Darien Way, the chord being N. 28-35 E. 80.0 feet to an iron pin on the southern edge of Darien Way; thence along the southern edge of Darien Way, N. 85-00 E. 250.0 feet to the beginning corner.

This conveyance is subject to utilities easements of record and is also subject to restrictions and protective covenants recorded in the R. M. C. Office for Greenville County in Deed Vol. 690, Page 531 as amended by subsequent restrictions recorded in Deed Vol. 758, at Page 116.
