

in the State aforesaid, in consideration of the sum of Six Thousand and No/100 (\$6,000) to Charlie P. Kellett, Dee S. Kellett, and Osby Woods and One and No/100 (\$1.00) to John Henry Kellett and other considerations Dollars

____in hand paid at and before the sealing of these presents

by W. B. Kellett and A. B. Sims

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said. W. B. Kellett and A. B. Sims, their heirs and assigns, forever:

all that piece, parcel or lot of land in Dunklin

Township, Greenville

County, State of South Carolina, on Little Horse Creek, branch waters of Reedy River, about twenty-one miles from the City of Greenville and about ten miles from Pelzer, on the Daventon Church Road, having the following metes and bounds, according to a plat made by W. M. Nash, and dated October 30, 1912, to-wit:

BEGINNING at a stone on a spring branch in the hole left by the stump of an ash 3x nm and running thence along line of land of D. Snipes S 15°W. 20.70 chains to a stone; thence S. 83 3/4° E. 2.03 chs. to a stone; thence S. 7 3/4° W. 15 chs. along line of land of Campbelltto a stone om; thence S. 81 1/3° W. 25.80 chs. along line of W. Va. Pulp and Paper Co.; thence N. 7 3/4° E. along lines of J. Walker Thompson, deceased, 36.53 chs. to a stone om; thence N. 82°10° E. along line of land of estate of James Scott, deceased, 19.9° chains to a natural stone, marked "X" on the spring branch first above mentioned, thence down said spring branch in a general easterly direction following the down said spring branch in a general easterly direction following the meanders thereof in a line about 5.36 chs. to the beginning corner, containing ninety acres more or less.

ALSO, all that certain tract of land situate, lying and being in Dunklin Township, County and State aforesaid, originally containing (148) one hundred and forty eight acres, more or less, now containing only 17 (seventeen) acres, more or less, (the remainder having been deeded to W.
