the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release
unto Theodore C. Buck and Mary M. Buck, their heirs and assigns, forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 139 as shown on a plat of Chevy Chase dated July 1963 by Dalton & Neves Engineers recorded in the R. M. C. Office for Greenville County in Plat Book YY, at Page 121, and having according to said plat the following description, to-wit:

BEGINNING on Christine Drive at joint front corners of lots 142 and 139 and running thence 90 feet with Christine Drive to an iron pin joint front corners of lots 139 and 137; running thence 175 feet along the side line of lot 137 to an iron pin at joint rear corners of lots 137, 138, 139 and 140; running thence 90 feet along the rear line of lot 140 to an iron pin at joint rear corners of lots 139, 140, 141 and 142; running thence 175 feet along the side line of lot 142 to the iron pin on Christine Drive, the point of beginning.

NO residence to cost less than Ten Thousand (\$10,000.00) Dollars shall be erected on said lot; no residence shall be erected on any lot unless said lot has seventy (70) feet, or more, frontage; no residence shall be erected on said lot nearer than thirty-five (35) feet to the front line; all lots to be used for residential purposes only, except lots fronting on Augusta Road; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

This conveyance is subject to all easements and rights of way of record.

Grantee to pay taxes for the year of 1965.
