All that lot of land in Greenville County, State of South Carolina, being shown as Lot 75 on a plat entitled West End Land and Improvement Company recorded in the RMC Office for Greenville County in Plat Book A at page 153 and having, according to said plat, and to a later plat entitled property of Charles Cely dated December 18, 1963, by J. C. Hill, R.L.S., the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Chapin Street at the corner of Lot 76 and running thence with the line of said lot, S. 79 W. 93 feet to a point on the eastern side of Palmetto Street; thence along the eastern side of Palmetto Street, S. 11 W. 50 feet to an iron pin at the corner of Lot 74; thence with the line of said lot, N. 79 E. 96 feet to an iron pin on the western side of Chapin Street; thence with the western side of Chapin Street, N. 14-10 E. 50.2 feet to the point of beginning.

Being the same property conveyed to the grantor by deed recorded in Deed Book 751 at page 501.

C. Cely, C. H. Cely, J. V. Cely, and R. E. Cely.

This property has been held by the grantor under the foregoing trust and it is the purpose of this deed to so declare.
