




Beginning at an iron pin on the northeastern side of South Carolina Highway No. 291, which iron pin is 2032 feet from the intersection of South Carolina Highway No. 291 and Wade Hampton Boulevard and the joint corner of this tract and property now or formerly of Oliver Greene; running thence with the northeastern side of South Carolina Highway No. 291 N. 40-26 W. 200 feet; thence continuing with said highway S. 49-34 W. 50 feet; thence continuing with said highway N. 40-26 W. 408 feet to an iron pin; running thence N. 49-44 E. 313.1 feet to an iron pin; running thence S. 86-23 E. 242 feet to an iron pin; running thence N. 4-30 E. 212 feet to an iron pin; running thence S. 83-0 E. 110.7 feet to an iron pin on the southwestern side of White Oak Road; running thence with the western side of White Oak Road the following courses and distances to-wit: S. 27-57 E. 18-.6 feet, S. 15-53 E. 179.9 feet, S. 6-36 E. 238 feet to an iron pin in the property line new or formerly of Oliver Greene; running thence with the Greene property N. 86-28~W. 319.5~feet; thence continuing with the Greene property S. 4-30 W. 267.5 feet to an iron pin, point of Beginning.
