ALL that certain piece, parcel or lot of land, situate, lying, and being on the Northern side of Tucson Drive near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 35 as shown on a plat of Western Hills, Section 2, prepared by Jones & Sutherland, Engineers, dated March, 1959, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book KK at page 130 (also recorded in Plat Book QQ at pages 98 and 99) and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Tucson Drive at the joint front corner of Lots Nos. 34 and 35 and running thence with the line of Lot No. 34 N. 0-15 E. 150 feet to an iron pin; thence N. 89-45 W. 190 feet to an iron pin at the joint rear corner of Lots Nos. 35 and 36; thence with the line of Lots No. 36 S. 0-15 W. 150 feet to an iron pin on the Northern side of Tucson Drive; thence with the Northern side of Tucson Drive S. 89-45 E. 190 feet to the point of beginning.

This is the identical property conveyed to Grantors herein by deed of W. D. Shedd, dated September 30, 1964, and recorded in the RMC Office for Greenville County in Book 760, Page 511.

The Grantee herein assumes and agrees to pay the balance due on that certain mortgage given by W. D. Shedd to Carolina Federal Savings and Loan Association of Greenville, dated October 30, 1964, and recorded in the RMC Office for Greenville County, South Carolina, in the original amount of \$9,000.00, on which there is a balance due of \$8,928.02, as of this date.
