KNOW ALL MEN BY THESE PRESENTS, that W. James Williams, as Trustee for W. N. Leslie,

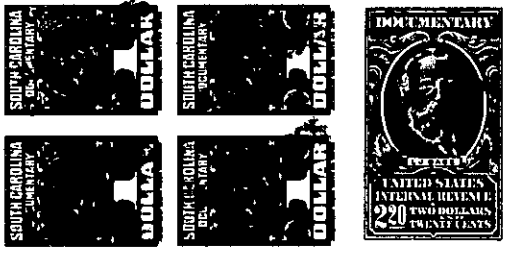
