All those pieces, parcels or lots of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the southern side of West Montclair Avenue (formerly Fairview Avenue) and being known and designated as Lot No. 17 and 1/2 of Lot 16, Block G, of Highland Terrace, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "K", at Page 121 and having, according to said plat, the following metes and bounds, to-wit:
