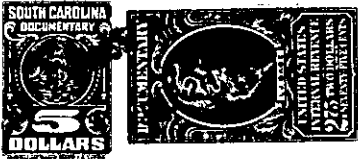
KNOW ALL MEN BY THESE PRESENTS, that I, William M. Edwards
