the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Alice Lee McCraw, her heirs and assigns:

ALL that certain piece, parcel or lot of land on the west side of Fourth Avenue in Section No. 2 of Judson Mills Village in the County of Greenville, State of South Carolina, being known and designated as Lot No. 39 as shown on a plat of Section No. 2 of Judson Mills Village made by Dalton & Neves, Engineers, in November, 1939, which plat is recorded in the R. M. C. Office for Greenville County in Plat Book K, at page 25, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwest corner of the intersection of Fourth Avenue and Sixth Street, and running thence with the north side of Sixth Street N. 83-53 W. 124 feet to an iron pin; thence with the rear line of Lot 46, N. 6-07 E. 80.6 feet to an iron pin; thence with the line of Lot No. 38, S. 83-53 E. 124 feet to an iron pin on the west side of Fourth Avenue; thence with the west side of Fourth Avenue, S. 6-07 W. 80.6 feet to the point of beginning.

This being the same property conveyed to Sheridan M. McCraw by Judson Mills by deed dated the 30th day of December, 1939. Sheridan M. McCraw died intestate as will appear by the records of the Probate Court in Apt. _____ File _____ of Greenville County, leaving surviving him his widow, Alice Lee McCraw; two daughters, Genell McCraw Cordell and Emmera McCraw Godfrey; three sons, Wilson A. McCraw, Boyd Lee McCraw, and John J. McCraw; and the children of a deceased daughter, Florence M. Bayne (she having predeceased her father) who left surviving her a son, George Melvin Bayne, and a daughter, Rebecca Ann Bayne Masters.
