

in consideration of Thirteen Thousand, Five Hundred and No/100-----(\$13,500.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release James R. Couch, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southwestern side of West Sable Court, being known and designated as Lot No. 26 on a plat of Blue Mountain Park dated March 16, 1955 by James M. Beeson, Engineer, recorded in the R. M. C. Office for Greenville County in Plat Book EE, at Page 121, and being more particularly described as follows:

BEGINNING at an iron pin on the southwestern side of West Sable Court, joint front corner of Lots 26 and 27, and running thence with the joint line of said lots, S. 63-10 W. 136.8 feet to an iron pin on branch, joint rear corner of said lots; thence along the rear of Lots 26, 63 and 64, following the branch in a northwesterly direction, to an iron pin, joint rear corner of Lots 25 and 26; thence with the joint line of said lots, N. 63-10 E. 118.5 feet to an iron pin on the southwestern side of West Sable Court, joint front corner of said lots; thence with said Court, S. 26-50 E. 120 feet to an iron pin, point of beginning; being the same conveyed to me by Rex L. Carter on August 11, 1964, and recorded in the R. M. C. Office for Greenville County in Deed Vol. 757, Page 439.
