ALL my undivided ~~xxxxxxx~~ interest in and to that certain piece, parcel or lot of land situate, lying and being in Grove Township, Greenville County, State of South Carolina, on the eastern side of State Highway No. 20, shown as Lots Nos. 1, 2, and 3 and 4 on a plat of property of The Friendly Oil Co., prepared by C. O. Riddle, R.L.S., March 22, 1965, the same being recorded in the R.M.C. Office for Greenville County in Plat Book KKK at Page 89, and having according to said Plat the following courses and distances, to-wit:

BEGINNING at an iron pin at the joint front corner of Lots Nos. 4 and 5, and running thence N. 88-53 E. 125 feet to an iron pin; thence S. 3-42 E. 50.05 feet to an iron pin; thence N. 88-54 E. 67.5 feet to an iron pin; thence S. 1-06 E. 185.3 feet to an iron pin on the northern side of a State Road leading to the Estes Plant; thence along the northern side of said Road S. 82-36 W. 142.9 feet to an iron pin in the right-of-way line of State Highway No. 20; thence along said Highway N. 14-00 W. 100.65 feet to an iron pin; thence still along said Highway N. 12-16 W. 155.9 feet to the point of beginning.

This being the property conveyed to C. A. McAbee by two certain deeds recorded in the R. M. C. Office for Greenville County in Deed Book 156 at Page 202 and Deed Book 178 at Page 313. A strip of 30 feet, more or less, along the southern portion of said property, adjacent to the State Road leading to the Estes Plant, was acquired by the heirs of C. A.
