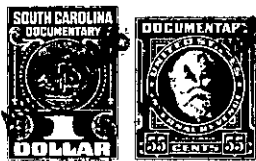

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto  
Helen R. Wood, her heirs and assigns forever:

All that certain lot or tract of land situate, lying and being in Chick Springs Township, Greenville County, South Carolina, being designated as Lot No. 2, on a plat entitled "Division of property of Louise R. McCain, Helen R. Wood, and Thelma R. Taliaferro", made by Terry T. Dill, Registered Engineer, dated February 1-2, 1965, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book XXX, page: 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of State Park Road (S.C. Highway No. 253), at the joint front corner of Lots 2 and 3, and running thence N. 23-30 W. 200 feet to an iron pin; thence S. 66-30 W. 240 feet to an iron pin; thence S. 23-30 E. 200 feet to an iron pin on the northern side of State Park Road (S.C. Highway No. 253); thence with the northern side of State Park Road (S.C. Highway No. 253) N. 66-30 E. 240 feet to an iron pin on the northeastern side of State Park Road (S.C. Highway No. 253), the point of beginning, and containing 1.10 acre.

AND ALSO: Lot No. 5 which is more particularly described as follows to-wit:

BEGINNING at an iron pin on the southern side of Mt. Creek Road joint front corner of Lots 4 and 5, and running thence S. 18-30 E. 236 feet to an iron pin; thence S. 66-30 W. 280 feet to an iron pin; thence N. 23-30 W. 235 feet to an iron pin on the southern side of Mt. Creek Road; thence with the southern side of Mt. Creek Road N. 64-35 E. 190 feet to an iron pin on the south side of Mt. Creek Road; thence with the south side of Mt. Creek Road N. 71- 55 E. 130.4 feet to an iron pin on the south side of Mt. Creek Road, the point of beginning, and containing 1.62 acres.
