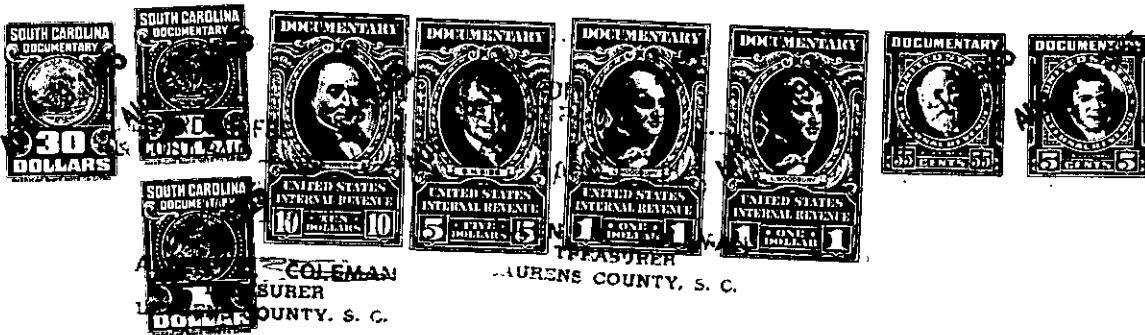
in consideration of SIXTEEN THOUSAND AND NO/100-----(\$16,000.00)----- Dollars,
