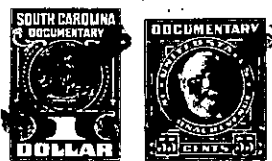
Know All Men by These Presents:

Bagwell and his heirs and assigns forever:

All that certain parcel or tract of land containing 2.31 acres, more or less, situated on the north side of Silver Lane Road in the Rocky Creek Community, Butler Township, Greenville County, State of South Carolina, and being Tract No. 3 of the property of O.H. Bagwell according to survey and plat by John A. Simmons, Registered Surveyor, dated August 12, 1965, and having the following courses and distances, to-wit:
