Fred P. Gibson, his heirs and assigns forever:

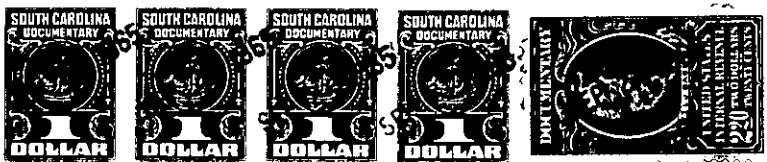
All that certain piece, parcel or lot of land lying and being on the northeasterly side of Theodore Drive near the City of Greenville, S. C., and being known and designated as Lot No. 8 on plat of Carolina Heights, as recorded in the RMC Office for Greenville County, S. C. in Plat Book BBB, page 29, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Theodore Drive said pin being the joint front corner of Lots 7 and 8, and running thence with the northeasterly side of Theodore Drive N 48-22 W 80 feet to an iron pin; thence on a curve, the chord of which is N 3-22 W, 35.3 feet to an iron pin on the southeasterly side of a 50 foot street; thence with the southeasterly side of said 50 foot street N 41-38 E 126.4 feet to an iron pin; thence S 48-52 E 105 feet to an iron pin, joint rear corner of Lots 7 and 8; thence with the common line of said lots S 41-38 W 152.2 feet to an iron pin on the northeasterly side of Theodore Drive, the point of beginning.

This conveyance is made subject to the rights-of-way and easements of record with respect to this lot.
