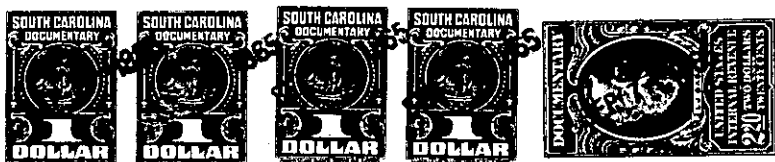

Greenville on the northeastern side of Ashwood Drive shown as Lot No. 207
on plat of Pineforest recorded in the R. M. C. Office for Greenville County
in Plat Book QQ at Page 106 and 107 and being further described as follows:

BEGINNING at an iron pin on the northeastern side of Ashwood Drive at the
joint corner of Lot Nos. 207 and 208 and running thence along the line of

thence along line of Lot No. 222 N. 61-53 W. 102 feet to an iron pin at
