

BEGINNING at an iron pin on the Eastern side of Endel Street at the joint front corner of Lots 11 and 12, which point is 103.5 feet Northeast from the intersection of Endel Street and Doe Street, and running thence with said Endel Street N. 24-36 E. 43.3 feet to an iron pin at the corner of Lot Number 13; thence with line of Lot Number 13, S. 66-20 E. 89.8 feet to an iron pin; thence with line of Lot No. 14, S. 26-07 W. 39.1 feet to an iron pin the rear corner of Lot Number 8; thence with line of Lot Number 8, S. 23-58 W. 3.6 feet to an iron pin the corner of Lot Number 11; thence with line of Lot Number 11, N. 65-54 W. 88.8 feet to an iron pin the point of beginning, and being the same property conveyed to Evelyn Judge from A. M. Goodlett on October 17,1963, said deed being recorded in the R. M. C. Office for Greenville County in Deed Volume 734 at page 91. - 519 -123-15-27
