to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s) Bill Compton and his heirs and assigns forever:

ALL MY RIGHT, TITLE AND INTEREST IN AND TO:

All that parcel or lot of land in Chick Springs Township of Greenville County, South Carolina, located about two miles south of the corporate limits of the City of Greer and about one mile south from the Pleasant Grove Baptist Church, lying on the southeast side of a new cut road which leads from Dillard Drive, said lot containing in the aggregate 49/100 of an acre, more or less, being shown on a plat made for Eugene B. and Lillian O. Cooper by John A. Simmons, Surveyor, dated October 24, 1961, amended on May 26, 1965, and April 6, 1965, and having the following courses and distances:

BEGINNING at an iron pin on the margin of said street, joint corner with the grantor's other lands, and runs thence S. 26-16 E. 172.9 feet to a stake; thence N. 62-31 E. 125 feet to a stake; thence N. 26-16 W. 167.8 feet to an iron pin on the new street; thence with the margin of said street, S. 64-51 W. 125 feet to the beginning.
