

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, being located on the northeastern side of Marlboro Drive and being known and designated as Lot No. 257, Section 3 of BELLE MEADE as shown by plat thereof recorded in the RMC Office for Greenville County in Plat Book GG at Page 187 and having, according to a more recent survey entitled Property of Clyde W.
