ALL that piece, parcel or lot of land situate on the North side of a surface treated road leading from Piedmont to the Augusta Road in Grove Township, Greenville County, South Carolina, containing 4.85 acres, according to a survey made by R. K. Campbell, November 16, 1957, and having, according to said survey, the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of a surface treated road leading from Piedmont to the Augusta Road at corner of property now or formerly of W. W. Hughey, and running thence along said Hughey Line, N. 78-02 E., 193.9 feet to an iron pin; thence continuing along line of W. W. Hughey property, N. 53-47 E., 827.7 to a point at the intersection of two county roads; thence along the center of a county road, S. 7-39 W., 599 feet to a point in the center of the surface treated road leading from Piedmont to the Augusta Roa'd; thence along the center of the said last mentioned road, N. 86-45 W., 599.5 feet to a point; thence continuing with the said surface treated road, N. 79-51 W., 182.6 feet to the beginning corner.
