That I, Lillian H. Schweikert

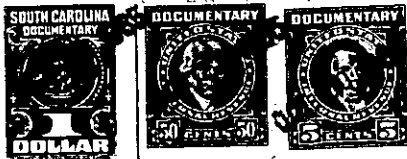
in the State aforesaid, in consideration of the sum of Three Hundred Fifty and No/100-----(\$350.00)----- DOLLARS,

ALL that certain piece, parcel or lot of land, being known and designated as Lot No. 61, of Section 6, according to a plat of the property of the Dunean Mills Subdivision by Pickell & Pickell, Engineers, as recorded in Plat Book S, pages 173 to 177, being more fully described as follows, to-wit:

BEGINNING at a point on the north side of Badger Street, said point being the joint front corner of Lots Nos. 61 and 62 and running thence along the line of Lot No. 62, N. 25-02 E. 114 feet to a point, joint rear corner of Lots Nos. 61 and 62; thence S. 80-56 E. 70 feet to a point, joint rear corner of Lots Nos. 60 and 61; thence along the line of Lot No. 61, S. 30-39 W. 136.1 feet to a point on the northern side of Badger Street, joint front corner of Lots Nos. 60 and 61; thence along the northern side of Badger Street, N. 62-27 W. 54 feet to the point of beginning.
