KNOW ALL MEN BY THESE PRESENTS, that I, WILLIAM MAXWELL,

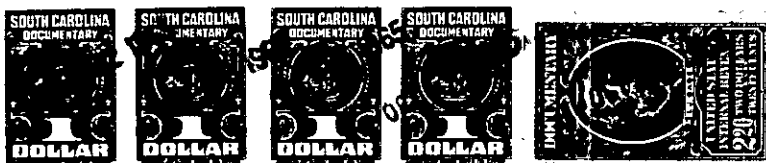
in consideration of -----Two Thousand and No/100----- (\$2,000.00)---Dollars,
