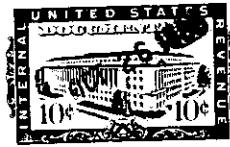

release unto Rufus G. Revis and Mary I. Revis, their heirs and assigns forever:

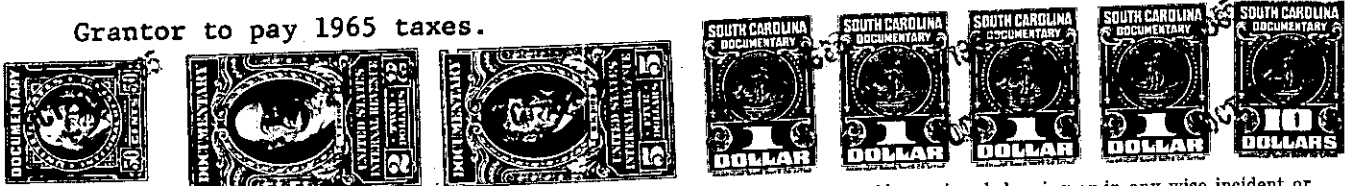
All that certain lot of land lying in the State of South Carolina, County of Greenville on the northern corner of Elmhurst Road and Westcliffe Way, near the City of Greenville, being shown as Lot No. 10 on a plat of Westcliffe, recorded in Plat Book YY at Pages 168-169 in the RMC Office for Greenville County and described as follows:

BEGINNING at an iron pin on the northern corner of Westcliffe Way and Elmhurst Road, and running thence with the northwestern side of Westcliffe Way, N. 57-00 E. 95 feet to an iron pin at the corner of Lot 11; thence with line of said lot, N. 33-00 W. 200 feet to an iron pin in line of Lot 9; thence with line of said lot, S. 57-00 W. 120 feet to an iron pin on Elmhurst Road; thence with the northeastern side of said Road S. 33-00 E. 175 feet to an iron pin at the corner of Westcliffe Way thence with the curve of the intersection, the chord of which S. 78 E. 35.4 feet to the beginning corner.

Being the same property conveyed to the Grantor by deed recorded in Deed Book 749 at Page 432.

As part of the consideration the Grantees assume and agree to pay the balance due on a mortgage to Fidelity Federal Savings & Loan Association in the original amount of \$17,500.00 recorded in Mortgage Book 961 at Page 439 in the R.
