All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, known and designated as Lot No. 13, Block L, as shown on plat of Fair Heights, recorded in RMC Office for Greenville County in Plat Book F, page 257, and having the following metes and bounds: Beginning at an iron pin on Fairview Avenue, joint front corner of Lot No. 12, and running thence along Fairview Avenue N. 31-47 E. 50 feet to iron pin, joint corner of lot no. 14; thence along line of lot no. 14, S. 58-40 E. 143.1 feet to iron pin, corner of lot no. 12; thence along line of lot no. 10, S. 31-20 W. 50 feet to iron pin, joint corner of lot no. 12; thence with line of lot no. 12 N. 58-40 W. 143.5 feet to beginning corner.
