All that piece, parcel or lot of land in Highland Township, County of Greenville, State of South Carolina located on the Western side of a County Road about three miles from Holly Springs and being shown as a 11 acre tract according to a survey and plat made for H. L. Fisher Estate by J. Q. Bruce, surveyor, dated 9-28-65 and having the following metes and bounds, to wit:

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

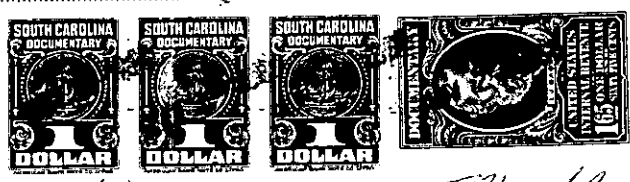

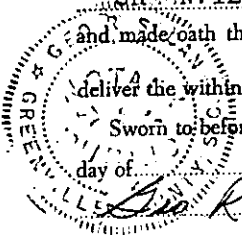

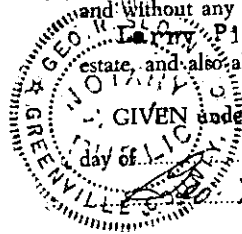
