BEGINNING at an iron pin on the northern side of Lee Road at the joint corner of Lots 6 and 7, and running thence with line of Lot No. 7, N. 15-25 E. 104.9 feet to an iron pin; thence S. 80-25 E. 88.6 feet to an iron pin at rear of Lot 5; thence with line of Lot 5, S. 14-27 W. 113.3 feet to an iron pin on Lee Road; thence with the northern side of Lee Road, N. 74-35 W. 90 feet to point of beginning.
