

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 5 of the Property of Central Realty Corporation according to a plat of record in the R. M. C. Office for Greenville County in Plat Book EEE at Page 108, and having the following metes and bounds, to wit:
BEGINNING at a point on the Northeastern side of Coquina Court at the joint front corner of Lots 5 and 6 and running thence with the Northeastern side of Coquina Court S 43-50 E 95.5 feet to a point; thence following the curvature of the Northwestern intersection of Coquina Court with Penarth Drive (the chord of which is N 88-16 E 26.8 feet) to a point; thence with the Northwestern side of Penarth Drive N 42-52 E 75.1 feet to a point; thence continuing with the Northwestern side of Penarth Drive N 46-28 E 75 feet to a point at the joint corner of Lots 4 and 5 thence N 43-50 W 109.5 feet to a point at the joint rear corner of Lots 5 and 6; thence S 46-10 W 170 feet to a point on the Northeastern side of Coquina Court at the point of BEGINNING.
