Owens, their heirs and assigns, forever: All our right, title and interest, being a 1/5 interest, in and to: All that certain piece, parcel or tract of land containing 32½ acres, more or less, situate, lying and being in Grove Township, Greenville County, South Carolina, lying on the northern side of Old Mill Road (now McMahan Road), and being shown on plat made by William F. Lee, November 22, 1893, being a part of Lot Nos. 3 and 6 in the division of the Old Richardson Lands, and having the following metes and bounds to-wit: BEGINNING at a stone X3 on the Old Mill Road and running thence N. 2-½ E. 35.00 to a stone X3, along the old T.
