KNOW ALL MEN BY THESE PRESENTS, that I, Vernon L. Bomar

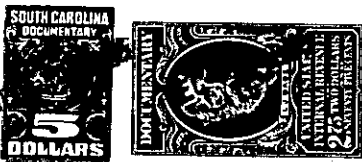
in consideration of Two Thousand Five Hundred and no/100 (\$2,500.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Cannon and Cannon, Inc., their successors and assigns forever:

ALL that piece, parcel or lot of land situate, lying and being in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lot No. 4 on a plat of Forest Hills, prepared by Carolina Engineering and Surveying Company, November 17, 1964, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "BBB", at page 45, and, according to said plat having the following metes and bounds, to-wit:

BEGINNING at the joint front corner of Lots Nos. 4 and 5 on the north side of Cannon Lane and running thence along the north side of Cannon Lane S. 53-16 W. 100 feet to the joint front corner of Lots 3 and 4; thence with the joint line of Lots 3 and 4 N. 36-44 W. 175 feet to the joint rear corner of Lots 3, 4, 14 and 13; thence along the joint line of Lots 4 and 13 N. 53-16 E. 100 feet to the joint rear corner of Lots 4, 5, 13 and 12; thence along the joint line of Lots 4 and 5 S. 36-44 E. 175 feet to the point of beginning.
