to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Taylors Water & Sewer District, its successors and assigns:

All of that 6" water main, together with fittings, valves and hydrants, if any, which was constructed within the right-of-way of Brushy Creek Road, beginning at a point at the intersection of Brushy Creek Road and Ike's Road, which point is a termination of that water main constructed by the Taylors Water & Sewer District, and running thence in an easterly direction to the boundary of the Taylors Water & Sewer District, and containing more specifically 400 linear feet of 6" pipe and one 6" valve.

The foregoing is situate on the within referenced road and is within the said County and State.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining
