HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said M. D. Byers

ALL that lot of land with the buildings and improvements thereon situate on the Southeast side of Lowndes Avenue, in the City of Greenville, in Greenville County, S. C., being shown as Lot 22 and a portion of Lot 23 on plat of Section B of Elletson Acres, recorded in the RMC Office for Greenville County, S. C. in Plat Book QQ, Page 5, and having according to said plat and a survey made by R. K. Campbell, September 14, 1965, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Lowndes Avenue, at the joint front corner of Lots 21 and 22, and runs thence along the line of Lot 21, S. 41-23 E. 167 feet to a point in the center of creek; thence along the center of the creek (the traverse line being S. 44-51 W. 109.8 feet) to an iron pin in the center of said creek at the joint rear corner of Lots 23 and 24; thence N. 34-51 W. 22 feet to an iron pin; thence through Lot 23, N. 40-10 W. 174.5 feet to an iron pin on the Southeast side of Lowndes Avenue, in the front line of Lot 23; thence with the curve of Lowndes Avenue (the chord being of Lot 23; thence with the curve of Lowndes Avenue (the chord being N. 58-0 E. 16.1 feet) to an iron pin; thence still with the curve of Lowndes Avenue (the chord being N. 49-24 E. 90 feet to the beginning -519-193,1-5-17
